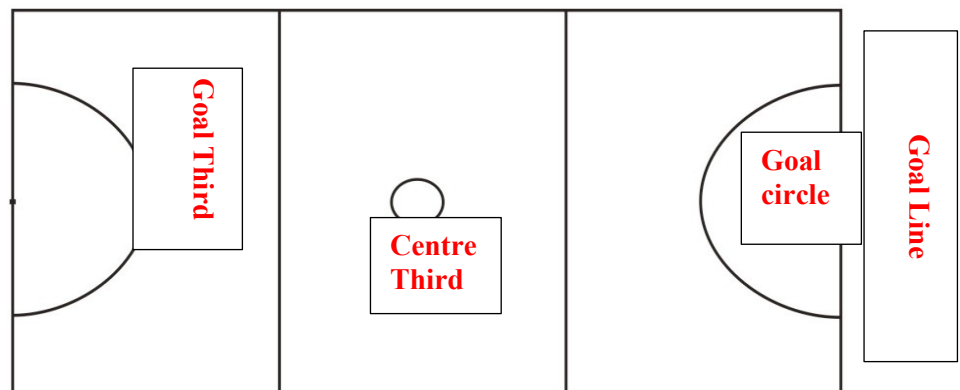
### Question 1

### Question 7

### Question 8

List 2 occasions when umpires blow the whistle?

- (1) **to start and stop the game, when time is called for injury/illness or blood**

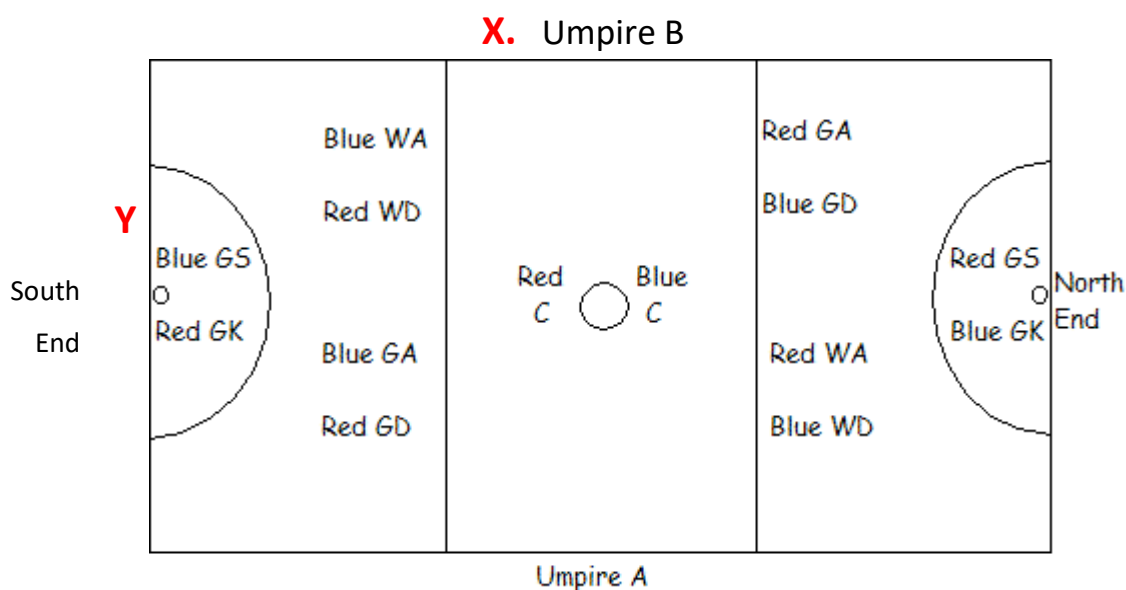

### Question 14

5 marks

Using the court below

### Question 15

5 marks

Study the Court above and answer the questions which follow.

- (a) Team Red have the first Centre Pass and are going towards North End.  
*Which umpire blows the whistle for the start of the game?* **UMPIRE A**
- (b) Team Red fail to score, Team Blue intercepts the ball and they score at the South end.  
*Which umpire blows the whistle for the next Centre Pass?* **UMPIRE B**
- (c) Team Red have the first Centre Pass after quarter time and are going towards the South End. *Which Umpire blows the whistle to start the second quarter?* **UMPIRE B**
- (d) Team Blue score a goal in the North End from their Centre Pass.  
*Who gets the next Centre Pass?* **TEAM RED**  
*Which Umpire blows the whistle?* **UMPIRE A**

**Question 16****2 marks**

At a Throw In, what must the Umpire check as the player throws the ball?

- (a) **All players are on court, thrower's foot is not more than 15cm from the line,**
- (b) **the player is not offside, does not step along the line and throws within 3 seconds.**

**Question 17****1 mark**

When is a goal scored?

**When the GS or GA throws the ball from within the goal circle and the ball passes completely through the goal ring**

**Question 18****5 marks**

Sanctions awarded for infringing are FREE PASS & PENALTY PASS.

Actions taken by umpires are THROW IN and TOSS UP.

What would you award for the following infringements?

- (a) Stepping in the Goal Circle **Free Pass**
- (b) Simultaneous Contact? **Possession**
- (c) Obstruction by GK in the Goal Circle? **Penalty Pass**
- (d) Contact by WA in the Centre Third? **Penalty Pass**
- (e) Ball lands out of Court? **Throw In**

**Question 19****1 mark**

Would you allow the GS to regain possession of the ball if it has **NOT** touched the Goal Ring or the Goal Post? Yes or No

**Question 20****2 marks**

Both the GS and GK, in possession of the ball, go offside at the same time into the Centre Third?

What would the Umpire's decision be?

**Possession to team who last had the ball**

**Question 21****1 mark**

Can a GA or GS who has been awarded possession in the goal circle take a shot at goal.

**Question 22****2 marks**

Use YES or NO to indicate whether a FOOTWORK infringement has occurred.

- (a) The Goal Defence lands on her RIGHT foot, jumps onto her LEFT foot and regrounds her RIGHT foot before releasing the ball? **YES**
- (b) The Wing Attack lands on BOTH FEET **simultaneously**, then lifts and regrounds her LEFT foot before releasing the ball? **NO**

**One player being within 0.9m of another player and then raising their arms**

**Question 26****2 marks**

(1) What is the sanction for obstruction if it occurs outside the goal circle?

**PENALTY PASS**

(2) What is the sanction for obstruction if it occurs inside the goal circle?

**PENALTY PASS****Question 27****3 marks**

(a) A player catches the ball and lands on their LEFT foot and then places their Right Foot in front of their LEFT foot. The opposing player's NEARER foot is 90cm from the LEFT foot when this player raises her arms to defend the ball.

**Is this player obstructing? NO**

(b) A player catches the ball and lands on BOTH feet at the same time. An opposing player standing within the distance of 90cm raises their arms to defend the ball.

**Is this player obstructing? YES**

(c) A player catches the ball and lands on their LEFT foot and then steps back on their RIGHT foot and lifts the LEFT foot off the ground. An opposing player places their nearer foot 90cm from the RIGHT foot.

**Is this player obstructing? YES**

**Why? Because they are within 0.9m of where the landing foot was on the ground**
